HHF plays a critical role in providing our communities with essential medical and nutritional care, including during all types of disasters, natural or man-made. We have built systems to allow us the continuity of essential services and a well-coordinated implementation of HHF operations at every level to quickly adapt to increased demands as well as the effective use of scarce resources.

Development:

Haitian Health Foundation's development program strives to work collaboratively with women, families and others who traditionally have no voice to help build vibrant communities across the greater Jeremie area.
