Haitian Health Foundation's healthcare strategies ensure access to either free or affordable health care that addresses primary, dental and mental health care needs of vulnerable and underserved children, women and families of the greater Jeremie region. There are five focused areas (1) primary care, (2) illness prevention, (3) health promotion, (4) community capacity building and (5) service integration.

During all types of disasters, natural or man-made, HHF plays a critical role in providing our affected communities with essential medical, hygiene, and nutritional care. Such disasters can lead to serious disruptions to the functioning of our communities as well as a rapid increase in demand for HHF services. We have built systems to allow for a quick response and the continuity of essential services through a well-coordinated implementation of HHF operations at every level to quickly adapt to increased demands.

4c (Code:) (Expenses \$ **1,095,506** including grants of\$) (Revenue \$)**Development:**

Haitian Health Foundation's development program strives to work collaboratively with women, families and others who traditionally have no voice to help build vibrant communities across the greater Jeremie area. This is achieved through the promotion of cleaner and safer construction of housing, distribution of goats for the purpose of food security and micro enterprising, sustainable agriculture strategies and micro lending.
